NOTICE IS HEREBY GIVEN that the San Rafael City Council will conduct a Public Hearing to receive public input and testimony regarding possible revisions to the San Rafael's City Council electoral district plan. Elections Code §§ 21621-21629 require the City to redraw its electoral boundaries every ten years, following the release of the Census.

The Public Hearing will be held at the regular meeting of the San Rafael City Council on Tuesday, February 22, 2022, and it will be held at 7:30 p.m. At the meeting the City's demographic consultant will present draft council district maps, including any submitted by the public, and seek public testimony regarding those maps. All interested persons are invited to participate and will be given an opportunity to be heard.
